President Matson called the meeting to order at 6:00 PM. Notice of the board's adherence to the Nebraska Open Meetings Law posted on the north wall of the meeting room was given.

Moved by Baker; seconded by Kolbet to approve the October Regular Meeting Agenda as presented. Aye votes Scott, Matson, Rippen, Baker, Kolbet, and Marks; nay votes none.

President Matson welcomed all visitors. A patron addressed the board.

Moved by Scott; seconded by Baker to approve the consent agenda. Aye votes Marks, Scott, Matson, Rippen, Baker, and Kolbet; nay votes none. The consent agenda consisted of the following items: (1) Minutes of the September 2015 regular board meeting. (2) The Activity Fund. (3) The bill rosters with general fund bills totaling \$286,679.32 and lunch fund bills totaling \$24,648.78. (4) Other funds.

Superintendent Apple welcomed and presented Marc Munford for Ameritas Investment Corporation to the board. Mr. Munford addressed various options to the board for refinancing the school bond. Other bonding firms be contacted for proposals.

Ms. McCarter addressed the board with information on the Junior/Senior High School's PBiS group. The PBiS team is having meetings with students and parents on positive reinforcements and expectations at home. PBiS has been a part of Hitchcock County Schools for nine years in the elementary and 5 years in the junior/senior high.

Superintendent Apple spoke with the NASB lawyer about building a storage shed on leased land. The building and grounds committee will meet at the site. Board member Rippen suggested contacting the Booster Club and the Hitchcock County Schools Foundation for help in costs.

Superintendent Apple reviewed NeSA test scores with board members.

Moved by Rippen; seconded by Baker to accept board policies 5021 – 5042 as presented. Aye votes Kolbet, Marks, Scott, Matson, Rippen, and Baker; nay votes none.

Board member Rippen gave a report on the NASB workshop he attended.

Principal/AD Kershaw's report as follows: (1) The NSAA is addressing a transgender policy. (2) Mr. Kershaw and Mr. Tines attended a Wellness Policy workshop in Kearney. The school's wellness policy was revisited and a team will be formed to make updates. (3) Fourth grade students attended a Health and Fitness Day on October 7<sup>th</sup> in McCook. (4) There will be a Red Cross blood drive at the elementary on December 3<sup>rd</sup> from noon to 6 PM. (5) The booster club will have a fundraiser for a student at the elementary on October 18<sup>th</sup>. (6) The cross country district meet will be in Grant on October 15<sup>th</sup>. (7) RPAC volleyball is October 19<sup>th</sup> and 20<sup>th</sup>. (8) Parent-Teachers Conferences will be held October 20<sup>th</sup> and 21<sup>st</sup> from 4 PM to 8 PM. (9) The zoo trip will be November 12<sup>th</sup> and 13<sup>th</sup>. (10) The elementary Veterans Day program will be held at 2 PM.

Superintendent Apple's report as follows: (1) Krutsinger Construction will be starting their project at the secondary site soon. (2) A review on conference schools and area enrollments. (3) REAP funds are being used to purchase more laptops for testing at the junior/senior high school. (4) Parent-Teachers Conferences will be held October 20<sup>th</sup> and 21<sup>st</sup> from 4 PM to 8 PM. (5) The school improvement team will be attending a

workshop in Kearney on October  $26^{\text{th}}$ . (6) Mr. Apple will attend the senator's roundtable on October  $21^{\text{st}}$  in North Platte.
