The Board of Education of the Hitchcock County Schools met May 11, 2020 at the Hitchcock County Jr/Sr High School. Present were board members Scott, Rippen, Kolbet, O'Byrne, Marks, and Hagan. Also present were Superintendent Sattler, Principal Tines, Ms. McCarter, K. Kisker and Peggy Fyn.

President Scott called the meeting to order at 7:00 PM. Notice of the board's adherence to the Nebraska Open Meetings Law posted on the east wall of the meeting room was given.

Moved by Kolbet; seconded by Marks to approve the May 2020 regular meeting agenda as presented. Aye votes Rippen, Hagan, Kolbet, Marks, Scott, and O'Byrne; nay votes none.

President Scott welcomed visitors. There were no comments.

Moved by Kolbet; seconded by O'Byrne to approve the consent agenda as presented. Aye votes Hagan, Kolbet, Marks, Scott, O'Byrne, and Rippen; nay votes none. The consent agenda consisted of the following items: (1) Minutes of the April 2020 regular board meeting. (2) The Activity Fund. (3) The bill rosters with general fund bills totaling \$390,105.16 and lunch fund bills totaling \$13,744.73. (4) Other funds.

Superintendent Sattler present the board with a letter of resignation from Mary Forch effective the end of the 2019-2020 school year. Moved by Hagan; seconded by Scott to accept the resignation of Mary Jo Forch, with many thanks and much gratitude for years of service to Hitchcock County Schools. Aye votes Kolbet, Marks, Scott, O'Byrne, Rippen, and Hagan; nay votes none.

The Nebraska Department of Education Administrative Review of the lunch program in February 2020 found the adult prices for breakfast and lunch lower than the required charge. Moved by Rippen; seconded by Hagan to approve an increase of adult meal prices to breakfast - \$2.50 and lunch - \$3.80 for the 2020-2021 school year as recommended by the NDE administrative review. Aye votes Marks, Scott, O'Byrne, Rippen, Hagan, and Kolbet; nay votes none.

Superintendent Sattler and the board members reviewed several events and activities that have been cancelled due to the Governor's health directive which closed school for the remainder of the 2019-2020 school year.

- a. Prom no date has been set
- b. Graduation dates were discussed and will be submitted to the SWNPHD for approval based upon the Governor's health directive.
- c. Athletics at this time some sports are being considered with many restrictions. There are no camps at present.
- d. Summer school the elementary will offer a summer school at home with handouts and Zoom meetings with the upper grades.
- e. Driver's Ed the classroom portion will be held on Saturdays when the new school year starts up, with driving being done as is possible.
- f. Summer weight lifting still in question. No more than 10 people can work out together with several restrictions. This is still being reviewed.
- g. Summer lunch program HCS will be offering meals throughout the summer until July 31.

Moved by Marks; seconded by Kolbet to move into executive session at 7:25 PM to discuss 2020-2021 personnel needs. Aye votes Scott; O'Byrne, Rippen, Hagan, Kolbet, and Marks; nay votes none.

Moved by Kolbet; seconded by Marks to move out of executive session at 7:52 PM. Aye votes O'Byrne, Rippen, Hagan, Kolbet, Marks, and Scott; nay votes none.

No action was taken.

There was no committee report.

Principal Tines' report as follows: (1) March 31st there was an all staff Zoom meeting. (2) April 6-10 the elementary had a virtual spirit week. (3) April 8th there was an all staff Zoom meeting. (4) April 14th – 16th elementary students picked up items in gym. (5) April 18th elementary staff had a parade through Culbertson and Trenton to wave at students. (6) April 23rd a Zoom meeting with teachers was held about a kindergarten split. (7) April 27th there was an all staff Zoom meeting. (8) April 29th – last mail out of student packets. (9) May 15th there will be a teacher meeting at 10 AM. (10) May 18th – 20th will be teacher checkout. (11) For K-3 Mrs. Haddix will send packets home to summer school students and for 4-6 grades Ms. Benson will send packets and have Zoom meetings for summer school students. (12) Mrs. Bohochik won a virtual tour with the Lincoln Children's Zoo.

Superintendent Sattler's report as follows: (1) There was approximately \$13,000 left from prepaid propane with the Farmers Coop and reimbursement has been requested. (2) The teachers will meet May 15th to finalize the end of the school year. (3) An Affidavit of Closure was filled out for the NDE. (4) Mr. Sattler, Mr. Tines, Ms. McCarter will be working on a continuity plan for the NDE for back to school in the 2020-2021 school year. (5) The school is keeping track of expenditures due to COVID 19 for the CARES Act. (6) Launch Nebraska is a website to plan for summer and the start of the fall school year, and professional development for teachers.

President Scott adjourned the meeting at 8:07 PM. The next board meeting will be held June 8, 2020 at 7:00 PM. The agenda kept continuously current is available to the public for items of an emergency nature. The meeting is open to the public.
